



Overview

The Learning Disability Partnership Board meeting held on the 28th of May 2024 was an interactive and fun event. The meeting was designed to foster equality, creativity, and collaboration, and it was a great success.

Introduction Activity

We began the meeting with an introduction session where each participant shared their dream job title. This exercise allowed us to throw away our normal labels and meet as equals, setting a positive and inclusive tone for the rest of the meeting.

Tower Exercise

The next activity was a challenge where we competed to build the biggest tower. The only rule was that each person touching the cards had to keep one hand behind their back. This exercise demonstrated our ability to think outside the box and highlighted the importance of discarding assumptions about limitations in order to achieve our goals.







I Know, I Love, I Do Activity

In the following exercise, we each reflected on what we knew, what we loved, and what we did. This activity revealed the diverse talents and interests within our group and helped us recognize the common threads that connect us.



Voting on the 7 Keys of Citizenship

We then moved on to vote on which of the 7 keys of citizenship we wanted to prioritize in our discussions over the next year. This session also included a talk on the voting

process, and we had the opportunity to hear from a council representative who is standing for election.



Charter Development

The final part of the meeting was dedicated to developing our charter. We paired up to discuss times when we felt a strong sense of belonging and drew out the values that emerged from these conversations. These values formed the foundation of our draft charter.
